

**Re: Structural Condition Report on Local Councils' Tribunal  
Premises at Ġnien l-Għannejja Żwieten off Triq San Tumas ,  
Żejtun.**

Arising from a recent site inspection carried out on 6th November 2020 , and subsequent enquires at Planning Authority web based records, I can certify and confirm the following:-

Tribunal premises is a one floor masonry load bearing structure largely rectangular in shape. Its external walls are built up of double skin soft stone globigerina limestone blocks and its internal walls are in single skin soft stone masonry walls. The slab is in reinforced concrete with a "Torba" laid to falls and an overlying concrete roof screed. Presumably a bituminous layer has been laid just below the "Torba" bed. The building's footprint is approximately 18.4 metres (m) in length and 13.79 m in width. Its superficial area has been calculated at around 250 square metres. Approximate layout in *Doc 5* refers.

*Doc's 1 to 4* are extracts from Planning Authority Geoportal Base Maps and Orthophotos dated 2016 Orthophoto for *Doc 1*, 1998 Orthophoto for *Doc 2*, 1966 Survey Sheet for *Doc 3* and 2020 Geoportal Base Map for *Doc 4*. Online Planning Authority records started being kept as far back as 1992. The block appears as already established in the 1998 Orthophoto but definitely was non-existent in 1968 Survey Sheet. Moreover, prior to the advent of the Planning Authority, Government entities were not required to apply for a building permit and thus actual lack of any planning application records before and after 1992 indicates that building was already erected before 1992. From its rather contemporary design outlook and elevational elements most probably it was erected in late 1980's and thus the whole premises is around 35 years old. Most significantly are the rectangular facade windows and doors with 2 courses high flat arches on both the facade's inner and outer skins. Flat arches, due to their geometry, are the weakest type of arches. However, due to the limited span of less than 2 m of the existing facade windows and doors, the employed 2 courses high voussoirs should have been more than capable to span adequately the apertures involved.

The whole building has been observed to suffer from noticeable rotational deformations arising most probably from weak foundations detailing. Photographic evidence in attached Photo Sheets referred. These rotational deformational movements in turn result in unsightly cracks along mortar joints in both internal and external vertical wall planes and the flat arches voussoirs joints. Other contemporary buildings in the near vicinity of the Tribunal premises, as indicated in attached photos numbered 23 and 14, do not exhibit any evidence of wall cracks

leading to the plausible assumption that no notorious weak bedrock strata in this zone of Żejtun actually exist.

Moreover, the medieval San Ġirġor Chapel, situated some 50 m away from the Tribunal site, is still structurally sound to present day. All this evidence strongly points out that the evident cracks, colloquially referred to as "konsenturi", are the direct result of bad workmanship and lack of adequate detailing at foundations level. A simple concrete reinforced strip footing foundation, that currently is almost universally employed in most construction sites, would have probably been enough.

Though presently of a rather insignificant structural considerations apart from their unsightly nature, where these cracks to become ever persistent and increase in width from just less than 1mm to at least 10mm, the vertical wall planes may become unstable and would render the whole premises dangerous to use. However, this scenario is far from the actual current site conditions and thus premises are safe to continue with their normal everyday use.

The current remedial action being undertaken by the Local Council is merely of a finishes aesthetical nature and is not actually addressing the inherent rotational deformations being exhibited. The latter cannot easily be structurally addressed, however, there is no immediate need to even consider very expensive structural interventions. Rotational foundations movements usually decrease in magnitude over time and eventually reach a stable stage. Hence, my advise is to monitor the deformations over a rather lengthy period of time, of say 2 to 3 years, by taking bi-monthly readings from simple deformation gauges fixed across the cracks in specific positions. Examples of these wall mounted deformation gauges, usually referred to as "Tell Tale" ones, are shown in Photo No. 16. If insignificant movements are recorded the gauges would then be removed and there should not be any more concern on the structural integrity of the premises.

Other defects photographed in photos 17 to 20 relate to the lack of rain water impermeability of the roof screed, particularly across its joints and screed to parapet wall joints. The Local Council of Żejtun should be urged to rectify the premises' roof screed as if left unchecked or not properly maintained for a few more years would lead to the spalling of the underlying concrete slab. The slab's natural carbonation process would be enhanced by the presence of trapped rainwater or water vapour, thereby shortening considerably its expected life span of around 70 to 80 years. Bearing in mind that premises is some 35 years old, proper roof screed maintenance is of paramount importance and should be actively pursued by the concerned entities.

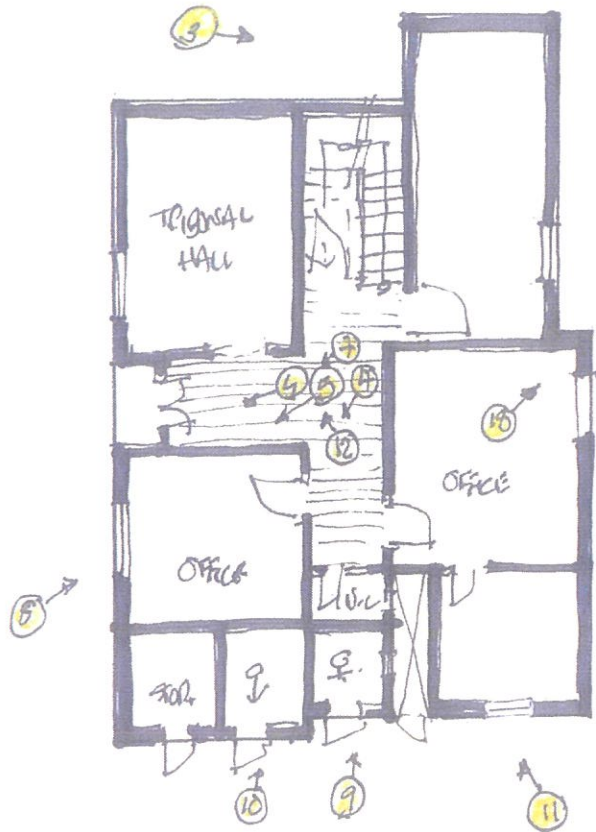

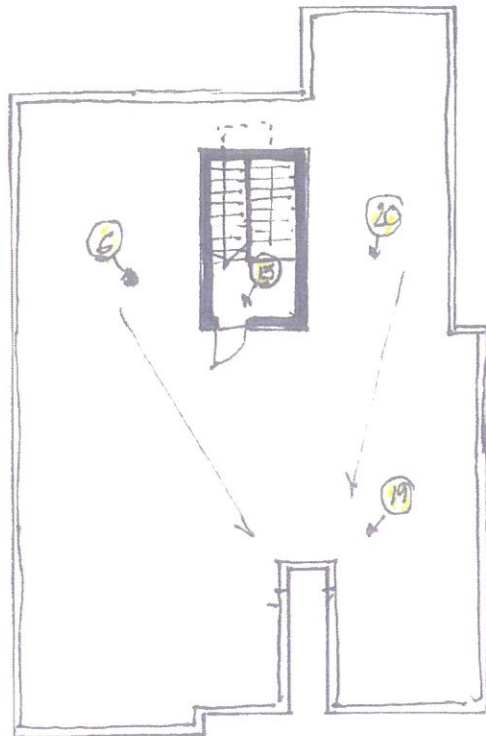

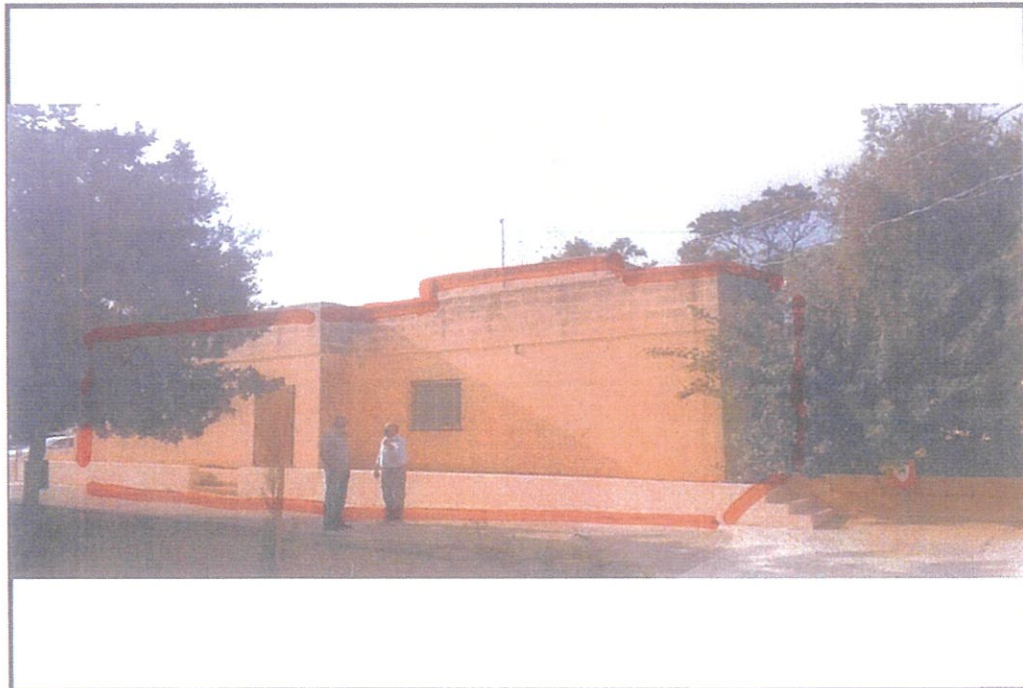

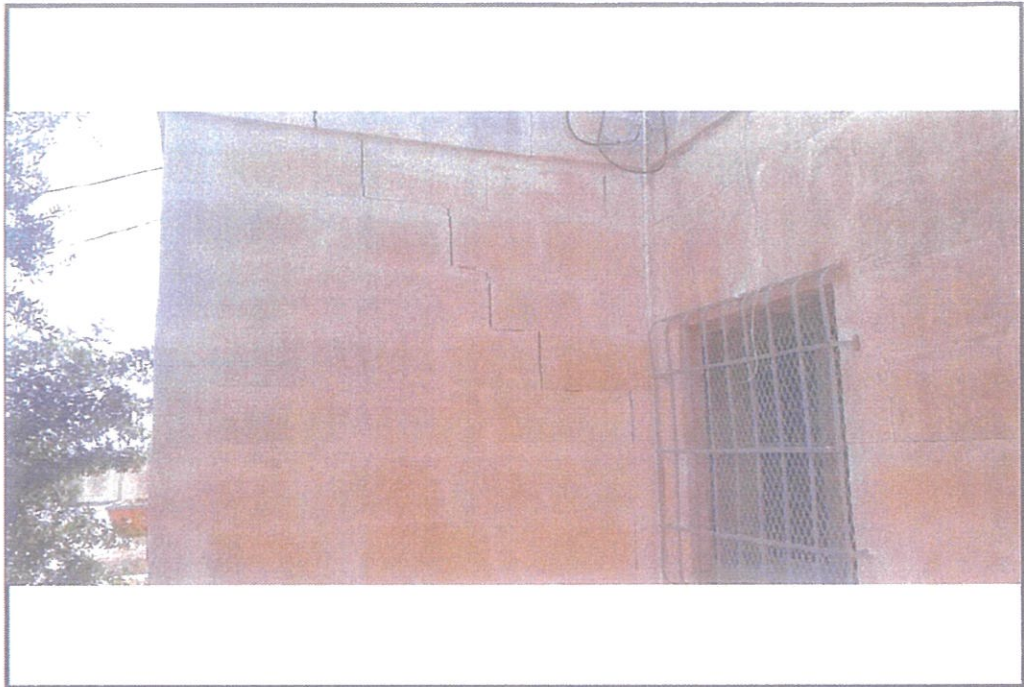


PHOTO No.3 -- Visible Rotaional Wall Crack ( Konsentura ) as seen on facade

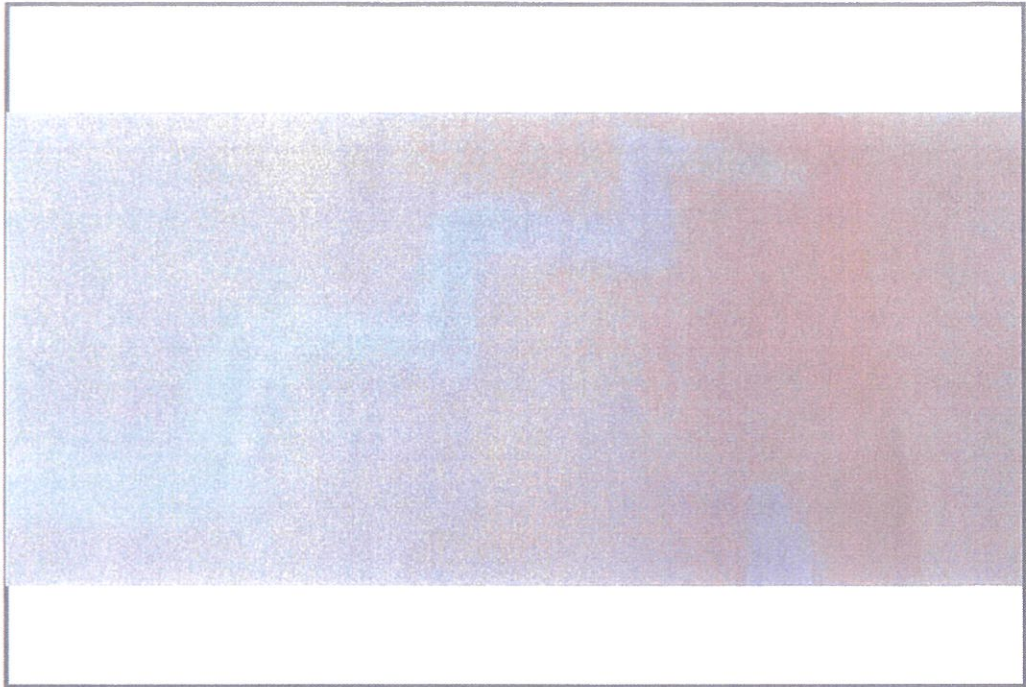


PHOTO No.5- Internal wall cracks recently plastered over

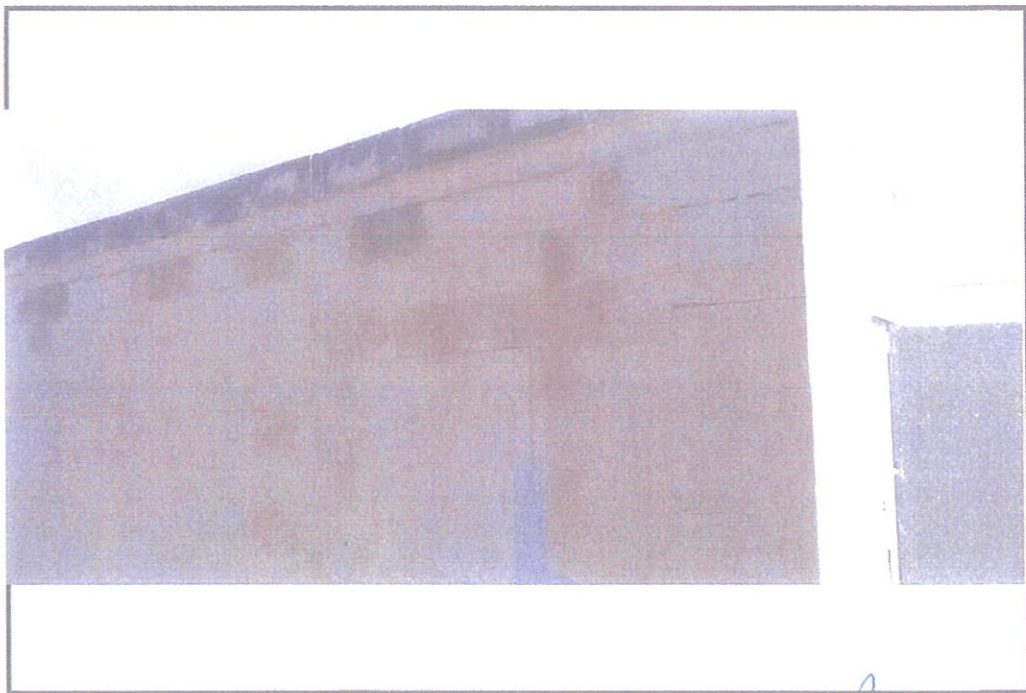


PHOTO NO.6-- Multiple external wall cracks on stairwell at roof level

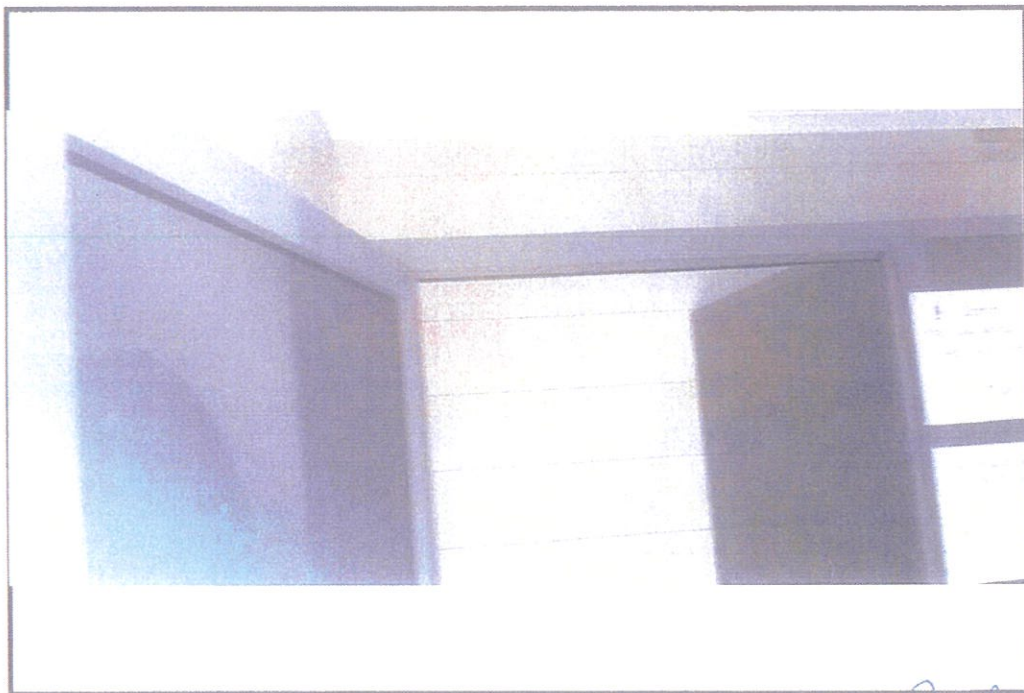


PHOTO NO. 10 -Similar to photo 9 for adjacent public sanitary facility

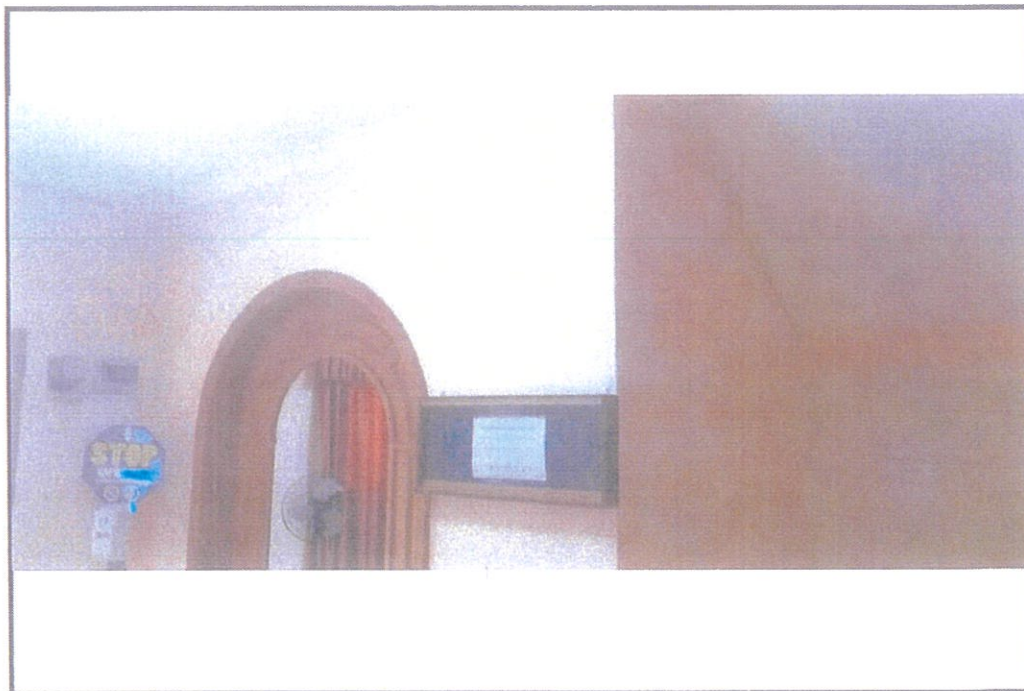


PHOTO NO. 12 - Wall cracks at internal corner of Tribunal Hall and over its arched entrance

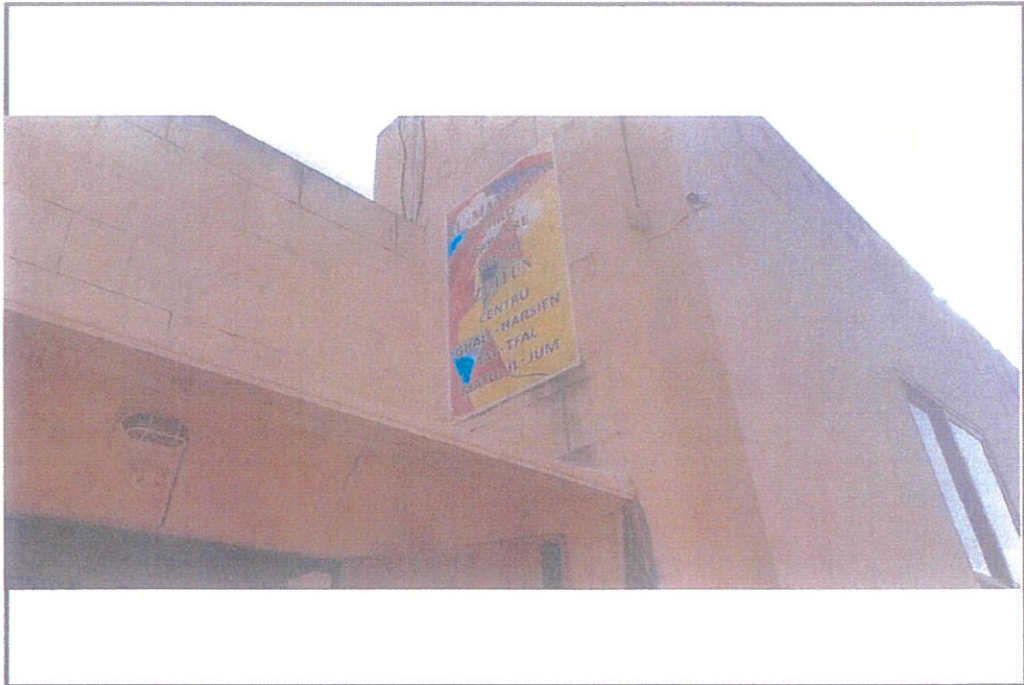


PHOTO No13 -nearby Child care centre with no visible Wall cracks

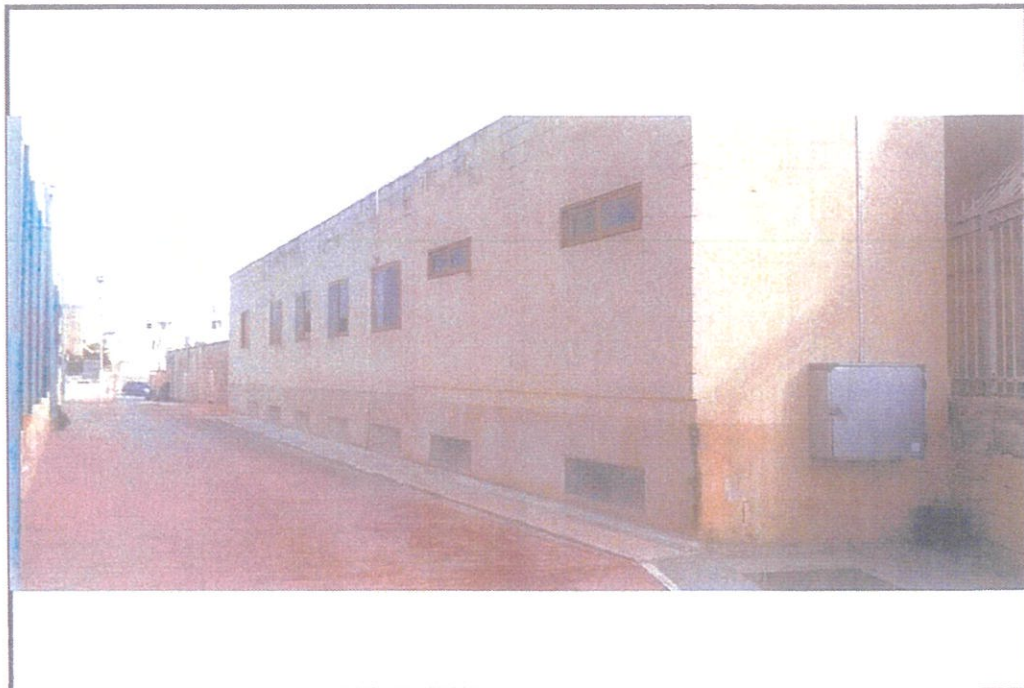


PHOTO NO. 14 - Child Care Centre

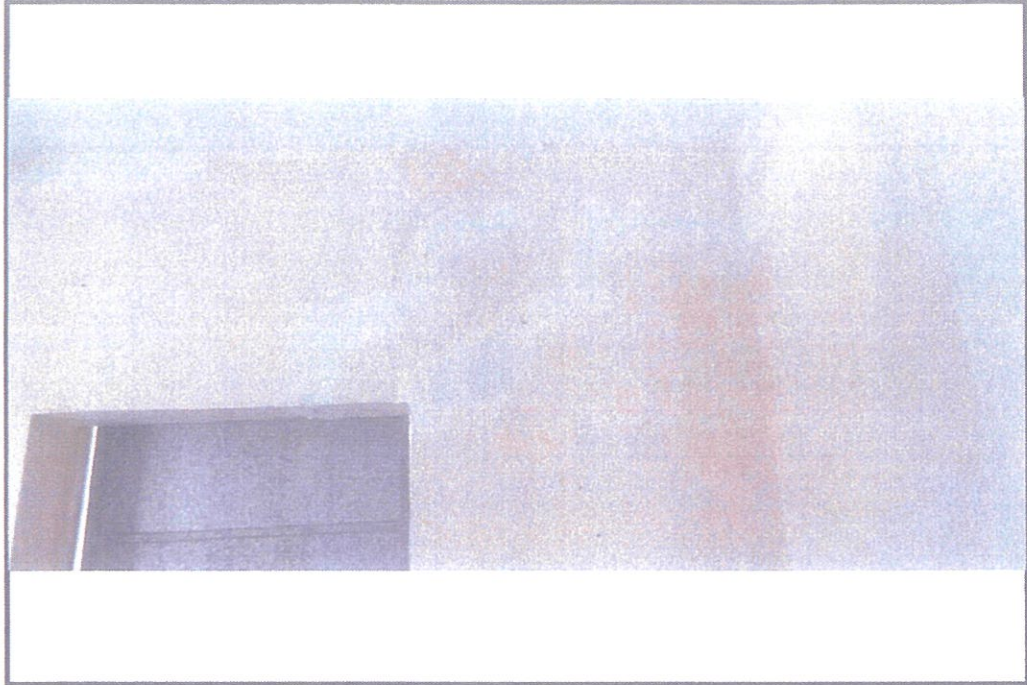


PHOTO No15 -Profuse internal wall cracks at roof level stairwell

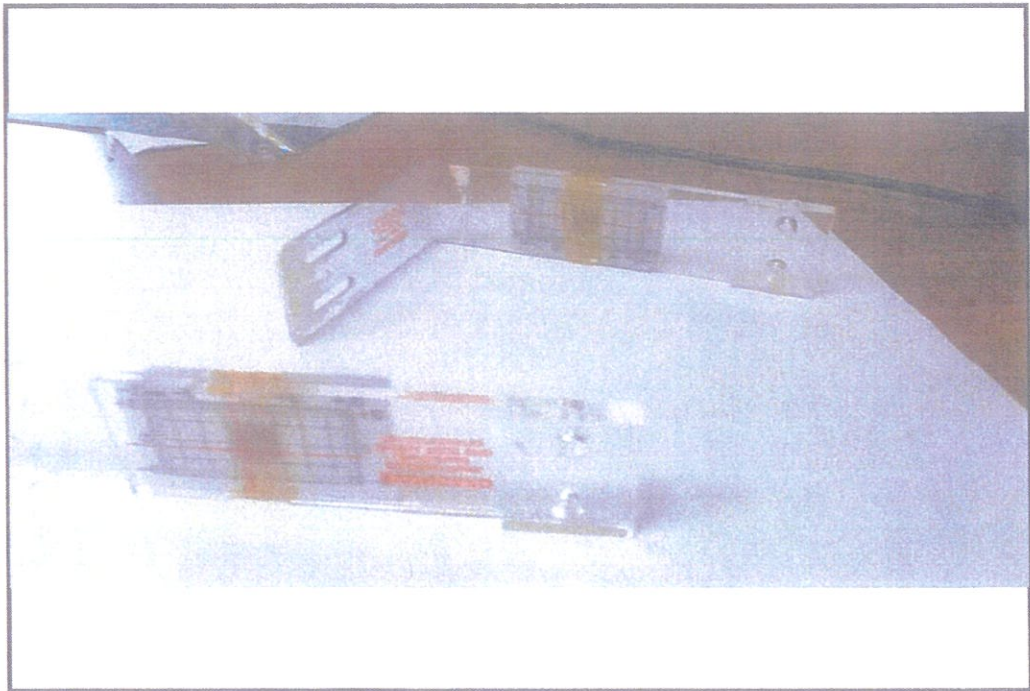


PHOTO NO. 16 - Plastice "Tell Tales" to monitor wall deformation across wall cracks
