28TH ECAD'S MAYORS CONFERENCE, MAY 2023

On May 11th, ECAD's 28th Mayors Conference, hosted by the Local Councils' Association Malta, took place in Qwara, Malta at the Dolmen Hotel. The Conference was attended by 75 participants. The majority of participants were local counsellors, NGOs, or representatives from the local authority from Malta. 7 more countries were represented at the conference, including Sweden, the United Kingdom, Ireland, Greece, Slovenia, etc.

Presentations were held on studies on workplace policy for addressing employees' substance misuse difficulties and the senior leadership teams' attitudes. Other presentations focused on the Planet Youth Model, best practices in pushing for prevention implementation, impacts of marijuana legalisation in Colorado, USA, and the Recovery Cities Model.

The second day of the Conference included a study visit to Komunita Santa Marija. Santa Marija is an in-house rehabilitation centre. The presentation given at the centre elaborated on the programmes provided and the phases that residents go through. San Patrignano is the largest drug rehabilitation community in the world, welcoming young men and women with drug abuse problems. Since 1978, it has provided over 25 000 people with a home, medical and legal assistance, while providing the possibility of continuing their studies, attending job training, and being reintegrated into society.

GÖRAN GREDFORS (SWEDEN) - CHAIRMAN

Göran is a full-time politician, a vice mayor and chairman of the social welfare community in his hometown Eskilstuna in Sweden.
