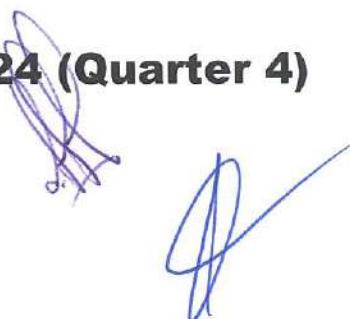

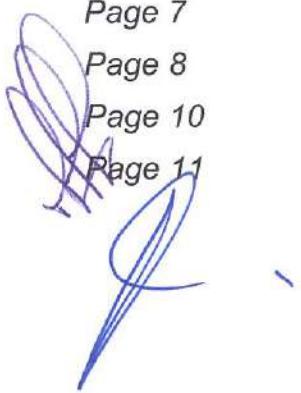

## Overview and Summary

### Introduzzjoni

Is-Sena 2024 kienet l-aktar sena impenjattiva mill-aħħar hames snin għall-Assocjazzjoni, fejn mhux biss saru l-elezzjonijiet lokali f' kull lokalita, imma wkoll l-2024 habtet it-tlettin sena anniversarju mit-twaqqif tal-Assocjazzjoni.

Kienet sena wkoll fejn rat ghadd ta' kunsilliera u Sindki eletti ġodda, li dan miegħu ġab certu sfidi, sfidi li setgħu u jiġu u ġeww indirizzati kieku l-Partiti ewlenin, hames snin ilu laqgħu it-talba tal-Assocjazzjoni li l-kandidati li jersqu 'l quddiem biex jikkontestaw l-elezzjonijiet lokali, jingħataw taħrif obligatorju bażiku biex ikunu jafu x' inhu mistenni minnhom kemmir-resident kif ukoll mill-att legali. Dan sabiex dan it-taħrif ikun mandatorju għall-kull kandidat.

Tul din is-sena kurrenti, saru bosta attivitajiet, kemm fuq livell ta' diskussjoni, strategija, taħrif, tharis ta' saħha mentali kif ukoll žvilupp personali. Thedew ukoll policies, fosthom fuq il-ħarsien tat-tfal f' ċirkostanzi fejn il-Kunsilli Lokali jaħdmu magħħom, policy fuq l-abbuż mis-sustanzi (alcohol, sustanzi illeciti u sustanzi ohra), kif ukoll sillabu ta' taħrif individwalizzat għall-haddiema kolha klarikali tal-Kunsilli Lokali, li se jkun ukoll parti mill-ftehim kollettiv li se jiġi iffirmat fil-jiem li gejjin.

### EXPO Gvern Lokali

Waħda mill-attivitajiet ewlenin ta' din is-sena kienet l-EXPO għall-Kunsilli Lokali u stakeholders ewlenij, sabiex taħt saqaf wieħed inġiebu flimkien il-Kunsilliera, Sindki u dawk kollha li b'mod jew ieħor jaħdmu, kemm dirett u indirett mal-Kunsilli Lokali u l-Gvern Lokali. Din kienet attivita maqsuma fuq tlett ijiem fejn taħt saqaf wieħed ippartecipaw 24 entita' governattiva, inžammu xejn inqas minn 29 workshop differenti, relatati mad-dekasteri tal-Kunsilliera, kif ukoll is-servizzi li dawn l-entitajiet joffru fil-kommunita. L-iskop kien li kull kunsillier responsabbli minn settur jew ieħor, ikollu l-viżibilita' u l-ghoddha meħtieġa biex imexxi d-dekastru rispettiv tiegħu bl-aħjar mod possibl u jkollu għarfien shiħ ta' dak li hu mistenni minnu. Din l-attivita hadet parti sostanzjali mill-Budget allokat mill-Assocjazzjoni għall-attivitajiet u peress li kienet qed issir ggall-ewwel darba, inqalghu stanzi fejn in-nefqa qabżet il-budget allokat għaliha. Dan ikkontribwixxa biex fl-aħħar kwart tas-sena, kien hemm varjanza bejn il-budget u n-nefqa attwali kif ukoll biex kien hemm żbilanč fil-financial Statement, li sa certu punt kien antiċipat. Dwar dan nagħti spjega aktar 'il quddiem.

### Plenarja tas-Sindki

Attivita oħra li orginārjament kienet programmata biex issir fi Frar tal-2025, iżda saret fl-aħħar kwart tas-sena, kient il-Plenarja tas-Sindki, li nżammet ġewwa Ghawdex. Din il-plenarja tmexxiet 'il quddiem għaliex kien hemm talba ġenerali mis-Sindki biex din issir din is-sena biex ma jkunx ghaddha wisq żmien mill-perjodu tal-hatra tagħhom f'Lulju tal-2024. Habba f' hekk, in-nefqa ta' din il-laqgħa ma kienx ikkalkulat mil-budget tal-2024, propju għaliex kien ippjanat li ssir fl-2025. Dan ukoll ikkontribwixxa għal varjanza bejn il-budget u n-nefqa attwali tal-aħħar kwart tas-sena 2024, kif ukoll għall-iżbilanč aħħari tas-sena.

### Obligi barra l-Pajjiż

Tul l-2024, l-Assocjazzjoni onorat l-obbligi kollha tagħha barra minnxtutna, f' laqgħat statutorji, oħrajn ta' proġetti li daħlet fihom kif ukoll dwar temi li jolqtu l-Gvern Lokali b' mod dirett. Permezz ta' dawn il-proġetti, l-Assocjazzjoni mhux biss kabret l-gharfien u r-rispett lejn Pajjiżna u l-Assocjazzjoni nnifisha minn Pajjiż u Assocjazzjonijiet Ewropej imma wkoll irnexxila tikseb fondi addizzjonal biex ma tistriehx biss fuq l-allokazzjoni diretta li jtiha l-Gvern centrali.

## Overview and Summary

Konferma ta' dan huwa l-fatt li l-Assoċjazzjoni Kunsilli Lokali, għas-sena 2025 qed ġiet magħżula u fdata biex torganizza l-'All Digital Summit', li se jsir f' Settembru li ġej u li għalihi huwa stamt li ser jattendu madwar 350 delegat barranini. Ġiet magħżula wkoll minn CEMR, li hija l-Organizzazzjoni li tiġib fi ħdana l-Kunsilli lokal u regionali madwar l-Ewropa, sabiex torganizza wkoll il-Kunsill Generali tal-2026, li ilu ma jsir aktar minn tmien snin. Diskussionijiet dwar dan għadhom għaddejjin għaliex għad irid ikun hemm konferma mill-Assoċjazzjoni dwar l-assigurazzjoni tal-fondi meħtieġa sabiex dan ikun possibl li jsir.

Fuq livell internazzjonali wkoll, ingiebu minn barra, għadd ta' nies esperti f' 1ertu oqsma partikolari sabiex dawn taw taħriġ lill-Kunsilliera tagħna f' oqsma li jirrigwardjaw ir-responsabbiltajiet tagħhom.

### Il-Kuntratt tal-Kirja tal-binja tal-Assoċjazzjoni

Hawnhekk esperjenzajna dżappunt wara ieżor għaliex minkejja l-istirzi kollha li saru mill-Assoċjazzjoni mall-INDIS biex dan il-kuntratt jigi iffirms, kien hemm diversi drabi fejn l-istess INDIS ġassret appuntamenti fejn dan kella jsir. Dan minħabba li l-Assoċjazzjoni talbet għal estensjoni fit-tul tal-kuntratt minħabba investimenti li ser tkompli tagħmel fl-istess binja, fosthom sabiex il-binja tigħi acċessibli permezz ta' lift, kif ukoll għall-holqien ta' spazju miftuh, fejn il-parking area ser tinbidel fi ġnien. Dan sabiex nimxu mall-viżjoni tagħna u mmexxu b-eżempju, fejn għandu jkollna prioritajiet differenti mill-passat u l-vetturi privat ma jibqgħux jiġu meqjusa bħala priorita' f' kull progett maġġuri li jsir. Dan sabiex spazji simili jkunu priorita għar-residenti. Dan il-proġetti huwa ttammat li jinħarġu l-permessi tieghu għall-habta ta' Frar - Marzu 2025, u huwa għalhekk li qed ikun previst li r-riservi tal-Assoċjazzjoni ser jonqsu għaliex parti minnhom ser ikunu qed jintużaw għall- dan ilproġetti kapitali li imbghad se jżid l-assi tal-Assoċjazzjoni.

### Xogħol Strutturali

Tul is-sena 2024, l-Assoċjazzjoni kompliet tibni fuq is-snин passati sabiex tirrinova l-binja tagħha għalkemm mhux bir-ritmu tas-snin passati, minħabba s-sitwazzjoni tal-Kuntratt.

Fost ix-xogħolijiet li saru hemm; rinoval tal-uffiċċini kollha, set-up ġdid ta' lecture room żgħira attrezzata b' kollo għat-taħrif f' numru żgħir, board room ġidha, kichenette li tmur mal-board room il-ġidha, tkomplija tal-art kollha bil-parque, sistema ta' dawl ġidha f' parti tal-binja, irranġġar mill-ġidha tat-tolets u installazzjoni ta' showers, tiswija strutturali fis-saqaf tal-Hall, ir-roof garden kif ukoll sistema shiħa ta' irrigazzjoni biex tagħmel ir-roff garden wieħed sostenibbli. Dan wara li fis-snin ta' qabel kien hemm investimenti fuq l-aperturi biex sistema ta' dwal energy saving li jżommu minn telf ta' shħana u/jew kesha.

Dan kollu mhux biss biex ġiet imtejba l-binja b' mod strutturali imma wkoll biex inħoloq ambjent ferm aħjar għall-haddiema u kull min iżur il-post. Dan kollu sar b' għaqal u ppjanar bla ma kien hemm impatt negattiv fuq l-operat jew il-finanzi tal-Assoċjazzjoni.

### Allokazzjoni u Strategija

Tul l-2024, l-Assoċjazzjoni hadmet u se tkompli taddem fuq ristrutturar intern, kemm fuq bażi maniġerjali kif ukoll b' numru ta' haddiema addizzjonal. Dan sabiex tkun f' pożoizzjoni aħjar biex tkompli ttejjeb is-servizz li tagħti lill-Kunsilli Lokali kif ukoll biex tlaħhaq max-xogħolijiet u obligi tagħha kemm fuq livell lokali kif ukoll internazzjonali.

## Overview and Summary

Għal dan il-ġhan, l-Assocjazzjoni żammet laqgħat mall-Ministeru tal-Finanzi fejn hie spjegat dan it-tibdil u ghaliex hemm ħtiega li l-Assocjazzjoni jkollha allokazzjoni adekwata kif isir dak spjegat aktar 'il fuq. Tul dawn il-laqgħat intwera kif minkejja l-allocazzjoni li tingħata l-assocjazzjoni, din mhix biżżejjed tant li l-l-istess assoċċiazzjoni, b' għaqal jirnexxilha kull sena tiġġenera kwazi l-istess tal-allocazzjoni mogħtija lilha, sabiex tkun tista' tkompli tiffunzzjona.

Dan kollu ġie rikonoxxut u għas-sena 2025 l-allocazzjoni tal-assocjazzjoni żidiet minn 580K għal 900K. Dan se jgħin qattiegh għal għanijiet li huma spjegatifid-dettal aktar 'il fuq.

### Il-pożizzjoni finanzjarja tal-Assocjazzjoni

Sa mill-2021, kien antiċipat li n-nefqa rikurrenti tal-Assocjazzjoni ser tkun qed tiżdied sostanzjalment minn nofs l-2023 u tul l-2024. Għal dan il-ġhan, kif juru l-figuri t'�awn taht, l-Assocjazzjoni kieent ħadet ħsieb li tagħlaq is-snini preċedenti f'-surplus sabiex iku jista' jagħmel tajjeb għas-sena 2023 u 2024, sakemm tintalab iż-żieda fl-allocazzjoni kif spjegat. Fil-fatt, jekk wieżed iares lejn is-snini; 2020, 2021 2022 u 2023 isib il-figuri segwenti;

Dan juri li mill-2020 sa l-2023, l-Assocjazzjoni irnexxilha topera b' mod li dejjem żiedet ir-riservi tagħha bla ma naqqset mis-servizzi offrutti lill-Kunsilliera li tirrapreżenta. Id-differenza tan-nuqqas fir-riżervi għall-2024 hija attribwita għall-ispjega t'�awn fuq.

Għas-sena 2025, huwa stmat li l-Assocjazzjoni ser tagħlaq is-sena b' €10,160 surplus u b' riżervi ta' €685,370, minkejja li ser tkun qed twettaq iż-żewġ proġetti kbar li ssemmew aktar qabel. Dan juri li d-deficit tal-2024 mhux wieħed struttrat, tant li se jkun qed jii rkuprat fis-sena 2025, minkejja ż-żieda fl-ispejjes rikurrenti u dawk kapitali.

### Is-sena 2025

Għal darba oħra u għas-seba' sena konsekuttiva l-Assocjazzjoni irnexxilha tagħlaq il-'Quarterly reports' kif ukoll il-financial statements fil-ħin. Huwa stmat li l-audit tal-2024 jaġħlaq sa nofs Frar 2025 sabiex anki f' dan ir-rigward, ikunu nżammu sew id-deadlines stabbiliti fil-ligħi.

Tul l-ewwel xhur tas-sena, ser jihi assikurat ukoll li jingħalqu affarijiet pendi, bhal kuntratt tal-kera ma' INDIS, kif ukoll tiġi kkonferma l-allocazzjoni. Ser jitkomplew ix-xogħoliet u twettieq ta' proġetti bi shab ma stakeholders oħra u għal-darb oħra terġa ssir l-EXPO, fejn huwa l-ħsieb li din tikun miftuha għall-Pubbliku, sabiex inkomplu nressqu r-residenti vihi ix-xogħol li jagħmlu l-Kunsilli Lokali tagħna,

Ser ikun intensifikat it-taħrif mogħti u se nkomplu ninvestu f' aktar servizzi innovattivi għall-membri tagħna. Proġetti bħal-dak tal-assistena fis-saħħha mentali lill-membri tagħna se jkompili jkun qed jingħata u jitjieb fil-waqta li se nharsu lejn sorsi oħra ta' dħul sabiex ukoll jghinu fil-committments tagħħna bhal l-orgaizazzjoni tas-Summit, All Digital.

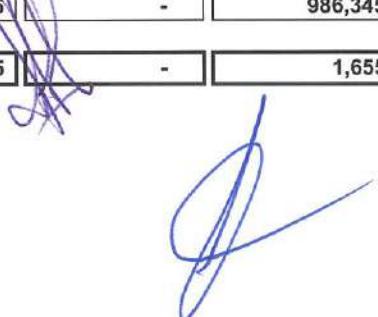

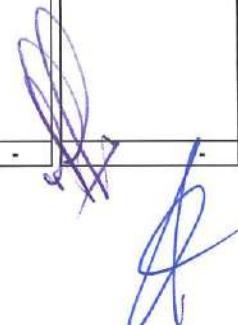
