Building Europe from the Ground Up – Local and Regional Voices in a Changing World

Across Europe, local and regional governments are navigating an increasingly complex and fast-evolving environment. Demographic transitions, geopolitical tensions, and shifting investment priorities—at both EU and national levels—are converging to create new challenges and expectations for subnational governments. These developments highlight the urgent need for place-based and territorially sensitive policymaking that reflects Europe's rich diversity and ensures that no community is left behind.

At a time when the European Union prepares for a new strategic cycle—framed by the Multiannual Financial Framework (MFF) 2028–2034—local and regional governments must not only adapt to new realities but actively shape the emerging European agenda. With growing emphasis on defence, industrial competitiveness, innovation, and resilience, it is critical to reaffirm the fundamental role of territorial cohesion, social equity, and democratic inclusion in future EU strategies and funding mechanisms.

In this context, the **CEMR Leaders' Summit** will provide a high-level political platform to amplify the voice of Europe's local and regional leaders. Taking place in Malta, this edition carries particular significance as it will coincide with the renewal of the CEMR Policy Committee and the election of new political leadership for the next three years.

Over two days, the summit will bring together elected representatives, policymakers, and institutional partners from across Europe to engage in strategic dialogue, influence EU policy debates, and agree on collective actions. The agenda will tackle demographic transitions, territorial disparities, and the evolving role of local and regional governments within EU governance and investment frameworks. Through interactive formats such as the **Impact Lab**, the summit will foster exchange, peer learning, and joint advocacy for a more cohesive, resilient, and inclusive Europe.
